(a) **BC Transit – Medium Bus Exchange**

(e) Vancouver Coastal Health – Public meeting held 3 June 2014 at Bella Coola Hospital and Bella Bella Hospital 4 June 2014.

The Chief Administrative Officer attended the VCH public meeting in Bella Coola. The purpose of the meeting was to explain to the community how VCH plan to move forward, now they are responsible for the Bella Coola and Bella Bella Hospitals.

The Mission of the Central Coast Regional District is to foster the sustainable socioeconomic and environmental well being of the Central Coast through the professional and efficient delivery of mandated regional and community services

The VCH engagement team provided an overview to the big picture for the health care system in BC, talked about Vancouver Coastal Health and how they work in partnership with communities through mutual communication to ensure community values and needs are reflected in healthcare provisions. As part of their community engagement process they have a Community Engagement Advisory Network (CEAN), which they explained how it works and encourage those at the meeting to join.
