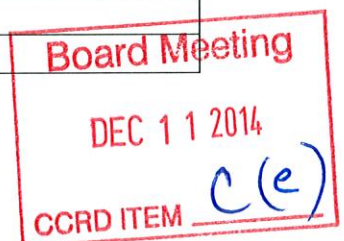
All School District positions were filled by acclamation therefore no voting took place.
