**Re: Request for Continued Participation on MaPP Advisory Committees**

The purpose of this letter is to request that your Board confirms continuation of Director Brian Lande as the Board representative to the Central Coast Marine Plan Advisory Committee (MPAC) and Regional Marine Advisory Committee (RMAC).

The Marine Planning Partnership (MaPP) is a co-led initiative between 18 coastal First Nations and the Province of BC to develop marine plans for the north Pacific coast of British Columbia. While originally scheduled to complete its work by December 2013, the Marine Planning Partnership initiative has been extended until June 30, 2014.

Director Lande has represented the Central Coast Regional District at the Central Coast MPAC meetings and the RMAC meetings from December 2012 to present as the Member. He has provided valuable advice and feedback regarding the development of the Central Coast Marine Plan and the Regional Management Plan. To date, a total of 8 MPAC meetings, 1 open house, 3 RMAC meetings, and 2 workshops were held during the process.

In an effort to ensure consistent representation for the Central Coast Regional District, we request a confirmation from the Central Coast Regional District Board of Directors assuring the continued participation of Director Lande at Central Coast MPAC and RMAC meetings and events from January 1 to June 30, 2014. In these final six months of the MaPP initiative, the Director will be expected to participate in 2-3 more MPAC meetings, 2-3 more RMAC meetings, open houses and continue providing advice on MaPP products.
