CENTRAL COAST REGIONAL DISTRICT
BYLAW NO. 420

A bylaw to amend Bylaw No. 405, 2011 cited as "Central Coast Regional District Hagensborg Centennial Pool Regulation Bylaw No. 405, 2011" setting the admission fees and user rates.

WHEREAS pursuant to Section 679(1)(a-f) of the *Local Government Act* the Board of Directors for the Central Coast Regional District may, by bylaw, make rules and regulations governing the management, operation, use and closure thereof;

AND WHEREAS the Board may fix and charge fees for admission or use of the Hagensborg Centennial Swimming Pool;

AND WHEREAS it is deemed necessary to amend these fees from time to time;

NOW THEREFORE the Board in open meeting assembled, enacts as follows:

- 1. The Hagensborg Centennial Swimming Pool is hereby authorized to be open during such periods as are specified hereunder:

May 15th to September 15th; seven days a week, 8:00 am to 9:00 pm.

- 2. The admission fees and user rates as set out hereunder are hereby authorized and fixed for the Hagensborg Centennial Swimming Pool:

3. No person shall, except upon written authorization of the Central Coast Regional District, enter upon or use the Hagensborg Centennial Pool during the periods or times of its closure as specified in Section 1.
4. Any person who violates any of the provisions of this bylaw shall, upon summary conviction thereof, be subject to a penalty not exceeding ~~Five Hundred~~ One Thousand Dollars (\$~~500~~1,000.00).
5. This Bylaw may be cited for all purposes as "Central Coast Regional District Hagensborg Centennial Pool Regulation Bylaw No. 420, 2013".
6. Bylaw No. 405, 2011 is hereby amended.
