**Re: Burnt Bridge flooding**

Thank you for taking time to meet with ministry staff recently to discuss the current flooding situation near Burnt Bridge along Hwy 20, and adjoining residences.

Our ministry is currently exploring options to assess the flooding within our Right of Way along Highway 20. We are aware of several residences that have been impacted by this recent flooding, as notably referenced in a letter addressed to the CCRD dated June 3, 2013.

As such, our ministry is proposing a review be conducted by a professional engineer (hydrologist) to complete an assessment of the areas impacted by the altered water course. The purpose of this study would be to provide recommendations and options to mitigate the flooding for all affected parties.

We would like to propose a cost share agreement between our Ministry, CCRD and locally impacted residences. The cost estimate for such a study could be in the range of \$20,000 to \$30,000, as a ballpark guess.

We sincerely look forward to hearing from you further with regards to this proposal.


